Question and Answer

July 15, 2022:

- Q1. Can DOTD provide a copy of the existing H.012685 LA 385 Ryan Street Intersection Stage 0 study?
- A1. The H.012685 LA 385 Ryan Street Intersection Stage 0 Study is located with Addendum No. 1 posted on the website today.
- Q2. Will DOTD require additional traffic counts to be collected for a supplemental traffic study?
