In accordance with Louisiana Revised Statute 48:293, this memorandum serves as documentation of selection of Richard C. Lambert (Number 2).

The advertised project description sets forth that the work is to provide construction contract administration and construction engineering inspection services for the above referenced project. Herein, the contracting entity will be the City of New Orleans. Design Engineering is the number 1 ranked firm by only 1.82 points. However, the average firm and staff rating of Richard C. Lambert was higher (4.06, 3.86) than Design Engineering (3.88, 3.74). More importantly, the City of New Orleans, the contracting entity, has recommended Richard Lambert based upon the rankings given by the City to these two consultants based on the management services pool for CE&I (Attached). The entity ranked Lambert #4 and Design Engineering #45.

For these reasons, I have selected Number 2.


